MIDLAND CITY COUNCIL MINUTES March 19, 2024



The City Council convened in regular session in the Council Chamber, City Hall, Midland, Texas, at 10:00 a.m., March 19, 2024.

The meeting was called to order at 10:00 a.m.

Finance Director Christy Weakland gave a brief five year budget forecast presentation. Ms. Weakland reviewed the budget and how it relates to the strategic plan beginning with the budget timeline, expenses vs revenues to FY2029, forecasted expenses, and revenue strategies.

City Manager Tommy Gonzalez provided additional information regarding certain aspects of the budget.

Ms. Weakland also reviewed the differences between using bonds vs cash and the 2023 audit which led to zero findings.

3e. Presentation from Director of Engineering Gabe McClelland regarding potholes.

Engineering Services Director Gabriel McClelland gave a brief presentation on potholes and how repairing them relates to the City's strategic goals to strengthen and sustain our infrastructure. Mr. McClelland reviewed historical PCI data, potholes by the numbers, pothole request and repair challenges.

Mr. McClelland encouraged citizens to report potholes so that they may be fixed on a more timely basis; saving the City money in the long run.

Mr. McClelland also reported on the street maintenance toolbox and in-house concrete paving.
